**1. List various communication strategies used in your school to provide additional information to parents and to increase parent and family engagement in supporting classroom instruction.**

- WCE will distribute the Lion's Den weekly newsletter to parents that is developed with participation of the parent school organization, principal, and staff. It includes school news, a calendar of school activities, and parenting tips related to school achievement such as homework tips, organizational skills, and study skills.
- Conway School District had created a district website to house school websites for each school. Information about homework assignments and pertinent school/classroom information will be available on the school website.
- Parents may use email to communicate with members of the school staff.
- Each teacher will send home a folder containing student papers and work samples each week. Parents will be asked to sign the folder and send it back to school.
- Teachers will routinely contact parents on an individual basis to communicate about their child's progress.
- WCE will provide to parents reports/report cards every nine weeks with information regarding their child's academic progress and upcoming classroom and school events.
- WCE will send parents a parent friendly letter in the first report card that explains their child's test results and standardized test scores.
- WCE will offer parents a special workshop each year on the school's approach to school improvement-State for the School Report.
- WCE will send brochures home with students, post notices in school facilities and public buildings.
- WCE will use the student handbook, school website, signage at the school entrance, and parent orientation meetings to give parents school information.

**2. List the proposed parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parent and family engagement and build staff and parent capacity to engage in these types of efforts. - Teachers will hold conferences individually with parents of children in their classrooms. Parents will be given a summary of the student's test scores and an explanation of the interventions teachers are using to assist the child in reaching achievement goals. Parents will be asked to engage in discussion of how they can support these efforts. Parents will also be given suggestions for coordinating school and parent efforts and explanations of homework and grading procedures.
